**TO: The Chief Justice of California and the Associate Justices of the
California Supreme Court**

Amici curiae Judith Wallerstein, Ph.D, Paulina Kernberg, M.D., Joyanna Lee Silberg, Ph.D., Julia M. Lewis, Ph.D., John Sikorski, M.D., and Stephanie Joan Dallam, RN, MSN, FNP, through their attorney Tony J. Tanke, hereby apply for leave to file their amici curiae brief in the above entitled cause, including one appendix that, when combined with the text of the brief, is within the word limits permitted by Rule 14(c)(1). The amici curiae brief accompanies this application and has been served on all parties to this case contemporaneously with its lodging in this Court.

The participants in this amici brief are developmental and clinical psychologists, child and adolescent psychiatrists, and researchers who have been deeply involved in clinical work with children and in the study of the impact of divorce on children and parents. They are well regarded both nationally and internationally. A brief description of their expertise in this area follows. Their curriculum vitae are attached

- Dr. Wallerstein is the world's leading expert on the effect of divorce on children. She has personally conducted and supervised long-term psychological research on the impact of parental separation and divorce on families and children of all ages, including a study of children of divorce spanning more

than 25 years. Represented by present counsel, Dr. Wallerstein filed an amica curiae brief in *Marriage of Burgess* ((1996) 13 Cal.4th 25). Dr. Wallerstein's curriculum vitae is attached hereto as Exhibit A.

- Dr. Paulina Kernberg is a nationally-recognized child psychiatrist who has conducted multiple research studies on developmental issues and has written extensively on children's issues, including divorce. She also teaches and supervises psychiatric residents at Columbia University. Her curriculum vitae is attached hereto as Exhibit B.
- Dr. Joyanna Lee Silberg is a child psychologist who has conducted and published research on assessment, evaluation, and treatment of children who suffer trauma, including abuse. Her work includes application of research findings to the protection of children in family courts. Dr. Silberg's curriculum vitae is attached hereto as Exhibit C.
- Dr. Julia Lewis is professor of psychology and coordinator of the clinical psychology graduate program at San Francisco State University. She has served as research director and co-principal investigator of the California Children of Divorce Project which has followed children of divorce for over 25 years. Her

curriculum vitae is attached hereto as Exhibit D.

- Dr. John Sikorski is a clinical professor in the Psychiatry and the Law Program of the Langley Porter Psychiatric Institute of the University of California, San Francisco. He has written extensively in the area children's legal issues, including custody. He has made multiple presentations to family court judges and attorneys. Dr. Sikorski's curriculum vitae is attached hereto as Exhibit E.
- Stephanie Joan Dallam is a research associate of the Leadership Council for Mental Health, Justice and the Media, a nonprofit independent scientific organization of scientists, clinicians, educators, legal scholars, journalists, and public policy analysts whose goal is to provide professionals and laypersons with accurate, research-based information about a variety of mental health issues, and legal/legislative editor of the *Family Violence & Sexual Assault Bulletin*. Her publications and presentations include legal and policy applications of research in the areas of child abuse, childhood trauma, and child custody. Ms. Dallam's curriculum vitae is attached hereto as Exhibit F.

The amici have no connection with the parties in this case and no personal interest in its outcome. In their proposed amici curiae brief, they will

endeavor to present to the Court results of social science research that they and other experts have conducted which bears, directly and indirectly, on the issues before the court.

Amici curiae understand that their proposed brief is being submitted to the court after the normal briefing times have expired. They ask the court to accept the brief outside these times, offering the following explanation:

The psychological literature dealing with the impact of divorce on children, adults, and society is rich and complex. Several new book-length studies on the children of divorce have appeared since *Burgess*. As a result, it has taken several months to prepare a brief that fully and accurately summarizes research, clinical observations, and legal discussion while avoiding technical language and duplication. Dr. Wallerstein, who has taken primary responsibility for the project, has a demanding schedule of writing, speaking, and travel, including international travel, that has not allowed her to be available full-time to review drafts and provide references. The logistics of circulating the brief among six amici for comment and revision and the checking of numerous social scientific publications have required additional time.

In addition, counsel for amici has had other pressing commitments that unfortunately have precluded full-time work on this project. These include eleven appellate briefs and petitions for review to be filed between mid-April

and the first week in June, a settlement in a complex multi-party case on appeal which required a week of full-time work in mid-April, and numerous out-of-town court appearances, trial-level case developments, and travel obligations in this time period.

For the reasons stated above, amici curiae respectfully request the court to permit the filing of their proposed brief, which has been duly and properly transmitted to all parties.
